**Note: Effective April 2, 2018, the passport acceptance fee (execution fee) will increase from \$25 to \$35 per application.**

<b>Passport Book - The fee for an applicant 16 years or older</b> is \$110.00 payable to the U.S. Department of State and \$25.00 payable to the Clerk of Superior Court. These fees are paid separately. The passport book may be used for all international travel by air, land, and sea to and from the U.S.	<b>\$135.00</b>
<b>Passport Book - The fee for a minor (under 16 years old)</b> is \$80.00 payable to the U.S. Department of State and \$25.00 payable to the Clerk of Superior Court. These fees are paid separately.	<b>\$105.00</b>
<b>Passport Card - The fee for an applicant 16 years or older</b> is \$30.00 payable to the U.S. Department of State and \$25.00 payable to the Clerk of the Superior Court. These fees are paid separately. The passport card may only be used if travel by land and sea from the U.S. to Canada, Mexico, the Caribbean and Bermuda.	<b>\$55.00</b>
<b>Passport Card - The fee for a minor (under 16 years old)</b> is \$15.00 payable to the U.S. Department of State and \$25.00 payable to the Clerk of the Superior Court. These fees are paid separately.	<b>\$40.00</b>
<b>Passport Book and Passport Card - The fee for an applicant 16 years or older</b> is \$140.00 payable to the U.S. Department of State and \$25.00 payable to the Clerk of Superior Court. These fees are paid separately.	<b>\$165.00</b>
<b>Passport Book and Passport Card - The fee for a minor (under 16 years old)</b> is \$95.00 payable to the U.S. Department of State and \$25.00 payable to the Clerk of Superior Court. These fees are paid separately.	<b>\$120.00</b>
<b>Expedited Service</b> - One way, overnight return delivery and expedited service is an additional \$75.89 per application to the U.S. Department of State.	<b>\$75.89</b>
