Passport Book - The fee for a minor (under 16 years old) is \$80.00 payable to the U.S. Department of State and \$25.00 payable to the Clerk of Superior Court. These fees are paid separately.	\$105.00
Passport Card - The fee for an applicant 16 years or older is \$30.00 payable to the U.S. Department of State and \$25.00 payable to the Clerk of the Superior Court. These fees are paid separately. The passport card may only be used if travel by land and sea from the U.S. to Canada, Mexico, the Caribbean and Bermuda.	\$55.00
Passport Card - The fee for a minor (under 16 years old) is \$15.00 payable to the U.S. Department of State and \$25.00 payable to the Clerk of the Superior Court. These fees are paid separately.	\$40.00
