Instructions for Filing a Foreign Judgment

In order to file a Foreign Judgment in the Superior Court of Arizona, the following is required:

1. A certified or authenticated copy of the judgment from the court in which it was rendered.
2. An Affidavit Substantiating a Foreign Judgment, setting forth the name and last known address for both the Plaintiff [Petitioner] Judgment Creditor and Defendant [Respondent] Judgment Debtor.
3. Notice of Filing Foreign Judgment.
4. A filing fee of \$286.00 (fees are subject to change). Form #102 (application for fee deferral) may be submitted if the funds to pay the filing fee are not available.
5. Provide original plus 2 copies of the documents being filed with the Court.
6. A cover sheet that applies to the specific case type you are filing, (civil or family court), Select form #414 or #415 (family court cover sheet, with children or without children); OR form #204 (civil cover sheet) from the Clerk's Office Fax-an-Demand or E-forms systems.
7. To request a certified copy of the filed-in Judgment from the foreign court, an additional \$.50 per page for the copy and \$26.00 for the certification is required.
