conclusion of the hearing in this matter. The new ballot count data moots the claims and 1 3 4 5 6 7

requested relief of Plaintiffs Donald J. Trump for President Inc. and the Republican National Committee. In addition, the new ballot count data all but certainly also moots the claims and requested relief of the Arizona Republican Party. The latter point will be a certainty by 3:00 p.m. today when the Maricopa County Elections Department finishes counting all ballots. At the time of this filing, the Statewide and Maricopa County ballot count data for the races identified by Plaintiffs as "close races" are as follows:

Because Plaintiffs acknowledged at the hearing that the relief they are requesting is only necessary if the vote counts in certain "close races" are such that adjudicating overvotes may make the difference between winning and losing a race, the Secretary wishes to inform the Court of the most recent data and Maricopa County Elections Department's plan to complete all counting by 3:00 p.m.

The Secretary and County Defendants respectfully request that the Court dismiss Plaintiffs' claims as moot.
