# MAKE TWO (2) COPIES:

2 After you have filled out the motion and Order make two (2) copies of each document.

## FILE ORIGINAL MOTION WITH CLERK OF THE SUPERIOR COURT:

3 File the original motion with the Clerk of the Superior Court, ask the Clerk to stamp the two copies.

### **GO TO COURT ADMINISTRATION Customer Service Window:**

Find out the name of the judge assigned to the case.

## **GO TO JUDGE:**

Deliver one copy of the motion and the original order to the Judge assigned to this case. After the Judge signs the order, you will be notified by the Court that the order has been signed.
